**Adjudicatory Hearings:**

1. Take action on a Consent Agreement between the Commission and Daniel Gorgone for a positive test on the horse, Canaco Oneida, following the Seventh Race at Scarborough Downs on October 16, 2010. Canaco Oneida tested positive for Phenylbutazone, a Class IV Drug.
2. Take action on a Consent Agreement between the Commission and W. Drew Campbell for a positive test on the horse, Grandma Finn, following the Tenth Race at Scarborough Downs on November 14, 2010. Grandma Finn tested positive for Trichloromethiazide and Hydrochlorothiazide, Class IV Drugs.

The remaining check(s) shall be returned to the unsuccessful claimants.
