# MAINE HARNESS RACING COMMISSION MINUTES OF MEETING

November 18, 2010 Conference Room, Gambling Control Board Department of Public Safety Office 45 Commerce Drive, Augusta, Maine

Commission Members Present: Chairman George McHale, James Tracy, Stanley Kuklinski, Barbara Dresser and S. Todd Bradley.

Commission Chair, George McHale, called the meeting to order at 12:40 p.m.

Commissioner Tracy made a motion to approve the following minutes as written. May 13, 2010; June 16, 2010; July 16, 2010; August 25, 2010 and September 21, 2010. Commissioner Kuklinski seconded. Vote 5-0.

### ADJUDICATORY HEARINGS:

- 1. Louis Gasbarro, III has agreed to enter a Consent Agreement with the Commission for a violation of Chapter 11 Section 3, Elevated Blood Gas. After a brief discussion, Commissioner Tracy made a motion to approve the Consent Agreement as submitted. Commissioner Bradley seconded. Vote 5-0.
- **2. Gordon DuBois** has agreed to enter a Consent Agreement with the Commission for a violation of Chapter 11 Section 3, Elevated Blood Gas. After a brief discussion, Commissioner Kuklinski made a motion to approve the Consent Agreement as presented. Commissioner Tracy seconded. Vote 5-0.

- **4. Philip (Bo) Sowers, Jr.** has agreed to enter a Consent Agreement with the Commission for a violation of Chapter 11 Section 3, Elevated Blood Gas. After a brief discussion, Commissioner Tracy made a motion to approve the Consent Agreement as presented. Commissioner Bradley seconded. Vote 5-0.
- **5. Bernard Charlton** has agreed to enter a Consent Agreement with the Commission for a violation of Chapter 11 Section 3, Elevated Blood Gas. After a brief discussion, Commissioner Tracy made a motion to approve the Consent Agreement as proposed. Commissioner Kuklinski seconded. Vote 5-0.
- **6. Timothy Hudson** has agreed to enter a Consent Agreement with the Commission for a violation of Chapter 11 Section 1, Prohibited Substance. After a brief discussion, Commissioner Tracy made a motion to approve the Consent Agreement as signed. Commissioner Kuklinski seconded. Vote 5-0.
- 7. **Megan Quinn** is alleged to have Violated MSHRC Rule Chapter 11 Section 1, Prohibited Substance. Ms. Quinn in the trainer of record of "Angel Left Behind". A urine sample obtained from "Angel Left Behind" following the Fifth Race at Topsham Fair on August 11, 2010 was found to contain Flunixin, a Class Four Drug. Mr. Jackson asked the Commission if they would continue this item to the December 9<sup>th</sup> meeting. Ms. Quinn has agreed to enter

into a consent agreement which has been mailed to her so that the consent agreement can be presented with her signature at the next Commission meeting. Commissioner Tracy made a motion to continue this item to the December 9<sup>th</sup> meeting. Commissioner Bradley seconded. Vote 5-0.

**Robert and Patricia Lupo** are the owners of record of "Angel Left Behind". "Angel Left Behind finished Second in the Fifth Race at Topsham Fair on August 11, 2010. Robert and Patricia Lupo were paid \$2,197.00 for "Angel Left Behind" finishing Second in the Fifth Race At Topsham Fair on August 11, 2010. Mr. Jackson asked the Commission if they would continue this item also to the December 9<sup>th</sup> meeting.

8. Richard Phaneuf is alleged to have violated MSHRC Rule Chapter 11 Section 3, Elevated Blood Gas. Mr. Phaneuf is the trainer of record of "Romi Mystic". A blood sample obtained from "Romi Mystic" prior to the Seventh Race at Scarborough Downs on September 5, 2010 exceeded the blood gas levels in Chapter 11 Section 3. Mr. Jackson stated that Mr. Phaneuf has agreed to a consent agreement and one has been forwarded to him for his signature. Mr. Jackson asked the Commission to continue this item, as well as Mr. Hall to the December 9<sup>th</sup> meeting. Commissioner Tracy made a motion that this item be continued to the December 9<sup>th</sup> meeting. Commissioner Kuklinski seconded. Vote 5-0.

**Edward Hall** is the owner of record of "Romi Mystic". "Romi Mystic" finished Third in the Seventh Race at Scarborough Downs on September 5, 2010. Edward Hall was paid \$540.00 for "Romi Mystic" finishing Third in the Seventh Race at Scarborough Downs on September 5, 2010.

- 9. **Michael Hitchcock** is alleged to have violated MSHRC Rule Chapter 11 Section 3, Elevated Blood Gas. Mr. Hitchcock is the trainer of record of "Fireball Fred". After a brief discussion, Commissioner Tracy made a motion to approve the consent agreement as presented as long as both purses have been returned. Commissioner Bradley seconded. Vote 5-0.

**Gardner Paterson** is the owner of record of "Take The Risk". "Take The Risk" finished Fifth in the Ninth Race at Cumberland Fair on October 2, 2010. Gardner Patterson was paid \$500.00 for "Take The Risk" finishing Fifth in the Ninth Race at Cumberland Fair on October 2, 2010.

**Shawn Nye** is alleged to have violated MSHRC Rule Chapter 11 Section 3, Elevated Blood Gas. Mr. Nye is the trainer of record of "Shagon Again". A blood sample obtained from "Shagon Again" prior to the Fourth Race at Bangor Raceway on October 18, 2010 exceeded the blood gas levels in Chapter 11 Section 3.

was paid \$1,150.00 for "Shagon Again" finishing First in the Fourth Race at Bangor Raceway on October 18, 2010

- Blood Gas. Mr. Thayer is the trainer of record of "La Vita Buona". A blood sample obtained from "La Vita Buona" prior to the Ninth Race at Farmington Fair on September 20, 2010 exceeded the blood gas levels in Chapter 11 Section 3. Mr. Jackson stated that Mr. Thayer has two positive tests. Commissioner Tracy made a motion to approve the consent agreement for Shawn Thayer as presented. Commissioner Kuklinski seconded. Vote 5-0.

  Shawn Thayer is alleged to have violated MSHRC Rule Chapter 11 Section 3, Elevated Blood Gas. Mr. Thayer is the trainer of record of "Casino King". A blood sample obtained from "Casino King" prior to the Ninth Race at Farmington Fair on September 25, 2010 exceeded the blood gas levels in Chapter 11 Section 3.
  - **Danny G. King** is the owner of record of "La Vita Buona and Casino King". "La Vita Buona" finished Second in the Ninth Race at Farmington Fair on September 20, 2010. Danny G. King was paid \$700.00 for "La Vita Buona" finishing Second in the Ninth Race at Farmington on September 20, 2010. "Casino King" finished Fifth in the Ninth Race at Farmington Fair on September 25, 2010. Danny G. King was paid \$375.00 for Casino King finishing Fifth in the Ninth Race at Farmington Fair on September 25, 2010.

Mr. Jackson asked the Commission to continue this item to the December 9<sup>th</sup> meeting. Mr. Jackson said that Mr. McEachern is home sick and has been offered a consent agreement like the ones above. Commissioner Tracy made a motion to continue this item to the December 9<sup>th</sup> meeting. Commissioner Bradley seconded. Vote 5-0.

**Richard Allaby** is the owner of record of "Bio Link". "Bio Link" finished Second in the Fourth Race at Bangor Raceway on October 18, 2010. Richard Allaby was paid \$575.00 for "Bio Link" finishing Second in the Fourth Race at Bangor Raceway on October 18, 2010.
